Albania Medical College Alopecia Clinic Sued for Research

Malpractice!

Albania (WHN) County prosecutors today announced that Dr. Harold (Harry) Coif has been charged with the misdemeanor crime of "Conducting An Experiment Without A Ph.D." as a consequence of his experimental treatment of Mr. Ned Ander-Thal of Clifton Park, NY.
