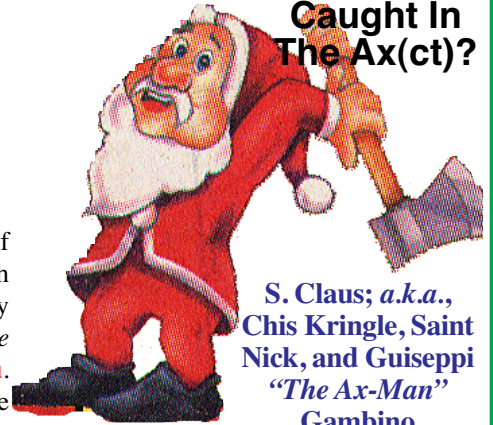

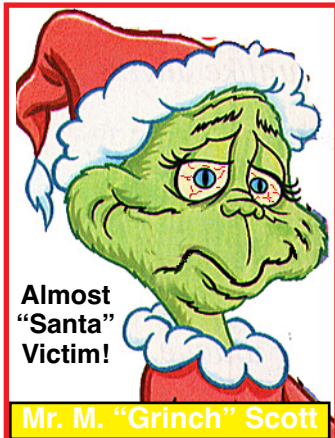

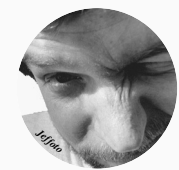
Found to Be In Violation of California Prop. 187!
